LIMITED WARRANTY For UniStar Series, UNINTERRUPTIBLE POWER SUPPLY PRODUCTS – DEPOT REPAIR OR REPLACE

General:

Staco Energy Products Co. ("Staco") products and systems are in our opinion the finest available. We take pride in our products and are pleased that you have chosen them. Under the circumstances set forth in this Limited Warranty Statement, we offer the following Limited Warranty Against Defects in Material and Workmanship ("Warranty") for the UniStar Series, UniStar V and UniStar VP Uninterruptible Power Supply Products (the "Products"). Read your Warranty carefully as it sets forth our responsibilities in the unlikely event of defect, and tells you how to obtain performance under this Warranty.

Terms of Warranty:

For Products sold to Users (defined below) in the United States, Canada, or Mexico, and provided that the other conditions of this Warranty stated herein are met, Staco warrants to the User that the Products covered by this Warranty will: (i) conform to the description of such Product contained in Staco's certified drawings and product descriptions ("Staco Descriptions"), and (ii) be free of defects in material and workmanship for a period of thirty-six (36) months from the date of shipment for all Products other than the UniStar SCL1924, which is covered by a separate Staco Limited Warranty. This Warranty for Products sold to Users in the United States, Canada, or Mexico covers only the labor and parts to remedy the defect, up to the replacement product cost of the Product; all other costs and expenses with respect to the defective Product shall be the cost of the User. For Products sold to Users outside of the United States, Canada, or Mexico, and provided that the conditions of this Warranty stated herein are met, the Warranty herein shall apply to defective parts only (all other costs and expenses with respect to the defective parts only (all other costs and expenses with respect to the User), and for a period of twelve (12) months from the date of shipment. The Batteries used in the Products are covered by Staco's Limited Warranty contained in the Staco Warranty Statement for Single-Phase Batteries for a period of twelve (12) months from the date of shipment.

Warranty Extends to First Purchaser for Use, Non-transferable:

This Warranty is extended to the first person, firm, association or corporation for whom the Product is originally installed (the "User"). This Warranty is not transferable or assignable without the prior written permission of Staco.

Warranty Claims Procedure:

User shall inspect the Product promptly upon receipt. User shall, within thirty (30) days after User's discovery of an alleged defect, contact Staco Field Services at 1-866-261-1191 and notify Staco of the alleged defect. User shall not return the Product with the alleged defect unless authorized by Staco, and all returns must be shipped freight prepaid to Staco at its Dayton, Ohio facility. Staco shall be entitled to inspect the Product to determine the coverage of this Warranty, and Staco, at its option, may accept written reports and photographs supplied by User detailing a claimed defect as evidence to allow coverage of this Warranty. For Products sold to Users in the United States, Canada, or Mexico, if Staco in Staco's sole discretion determines that the Products are defective in material or workmanship within the scope of this Warranty, then subject to the limitations and conditions specified herein, Staco's sole obligation will be to repair or replace, at Staco's option, the Products are defective in material or workmanship within the scope of this Warranty, then subject to the limitations and conditions specified herein, Staco's sole obligation will be to repair or replace, at Staco's option, the Products are defective in material or workmanship within the scope of this Warranty, then subject to the limitations and conditions specified herein, Staco's sole obligation specified herein, Staco's sole obligation shall be to provide replacement parts. Replacement parts or components ordered by User without an inspection of determination of defect by Staco, or otherwise not in accordance with these procedures shall be invoiced to User at the full current price for such parts and shall be shipped freight collect Ex Works Staco's facility.

Use of Component Manufacturers:

It is Staco's practice, consistent with its desire to provide warranty service in the most prompt and effective manner possible, to cooperate with and utilize the services of component manufacturers and their authorized representatives in the performance of warranty service. Accordingly, Staco may, in its sole discretion, utilize third parties for the performance of the warranty services described herein.

LIMITATIONS:

THIS WARRANTY AND STACO'S OBLIGATIONS HEREUNDER ARE CONDITIONED UPON PROPER INSTALLATION AND SYSTEM START-UP BY AN AUTHORIZED STACO SERVICE ENGINEER, AND TIMELY RECEIPT OF FULL PAYMENT FOR THE PRODUCT. THIS WARRANTY DOES NOT APPLY TO ANY PRODUCT THAT HAS NOT BEEN USED IN ACCORDANCE WITH ITS INTENDED USE OR WITH ANY INSTRUCTIONS FOR USE, HAS BEEN ALTERED OR MODIFIED IN ANY MANNER, OR HAS BEEN USED IN A NEGLIGENT MANNER. Any parts or materials not manufactured by Staco are warranted solely by the manufacturer of such parts or materials, and are not included as part of this Warranty. REPAIR OR REPLACEMENT OF A PRODUCT OR PART THEREOF DOES NOT EXTEND THE ORIGINAL WARRANTY PERIOD, and such items shall be warranted for the remaining portion of the original Warranty, subject to all of the terms thereof.
